Are injury prevention, environmental health and public health interconnected?

- Public health includes health protection
- Health protection includes environmental health
- Does environmental health include injury prevention?

What is Environmental Health?

- Those aspects of human health and disease that are determined by factors in the environment.
- The theory and practice of assessing and controlling factors in the environment that can potentially affect health

What is injury?

The acute transfer of energy from the *environment* to human tissue

- > Mechanical
- > Thermal
- > Electrical
- > Chemical

Or

impairment of bodily function due to lack of a vital environmental element (air, water, warmth)

"The term *environmental health* is associated overwhelmingly with a narrow range of activities centring on the enforcement of regulations relating to specific toxic, infectious or allergenic agents.

"...one of the most serious threats to human health
– injury – has been largely excluded from the
environmental health paradigm."

Our assertion

Injury is an environmental health issue *par excellence*.


Injury merits consideration as a major strategic priority by

- the public health community
- environmental health professionals

INJURY IS A GLOBAL PUBLIC HEALTH CHALLENGE

- Approx 5 million deaths annually worldwide
- Leading cause of death in children/young people
- Deaths are only tip of injury iceberg
- Injury mortality rising in developing countries, falling in developed
- Most injuries unintentional but pattern changing


ENFORCEMENT OF LEGISLATION

Pre-injury	Child running	Car speeding	Rain
Injury	Skull fracture	Bumper impact	Microbes
Post-injury	Coma	Unskilled first aid	Hospital care

UK initiatives on environmental health and children

 UK: Children's Environmental Health Strategy 2009

• Scotland: Good Places, Better Health 2008

Good Places, Better Health

- Aims to deliver environments promoting human health, wellbeing and equality of opportunity
- Initial priorities around child health, wellbeing and safety (IP)
- Focuses on need for better evidence to highlight gaps and point to solutions
- Linked to Environmental Determinants of Public Health in Scotland (EDPHiS), a multi-disciplinary study to support the policy development

Key messages


- IP already occurs in health promotion, consumer safety, occupational health, police, fire etc departments
- Efforts are fragmented, uncoordinated and hindered by the lack of a strategic "home" for injury prevention
- Integrating IP efforts within an environmental health strategic framework will promote effectiveness
- A robust infrastructure already exists for environmental health and health protection in the UK and elsewhere
- Delivery is possible with minimal additional resources

Conclusions

• IP's natural strategic "home" lies within environmental health and its broader domain of health protection

 This approach has potential to co-ordinate and enhance existing IP efforts

• Injury prevention and safety promotion should be strategic priorities for environmental health
